EPICMIX PASS: Tracking Lift Rides and Vertical

This season, CSCers will be able to track their lift rides and vertical on the Breckenridge & Beaver Creek trips. Both mountains are part of Vail Resorts and their tracking system...EpicMix. Last season was the beta trial for EpicMix and the Resorts had a terrific response. Lift tickets this year will be equipped with an RF logo on the back that can capture stats automatically as soon as you pass by a lift operator. Wear these passes on a lanyard or in a jacket pocket in the front and center of your torso to be easily scanned. Don't carry electronic devices or anything else in the same pocket or location as this may interfere with the scan process. Each participant can register and set up an online account via computer or mobile phone (there is an app for iPhones and Androids).

EpicMix calculates your vertical feet based on your lift rides on the mountain. The difference between the elevation of the top of the lift you got off of, and the elevation of the bottom of the lift you get on next, equals the vertical feet covered by that run. When you leave for the day, and stop riding lifts, it knows you have left the mountain and can add the vertical feet covered for your last run of the day to the day's total. Based on your activity and exploration on the slopes, you will earn pins. Pins are determined by where, when and how often you ski and ride at all six resorts. 2012 FSA TRIP

CRESTED BUTTE ... "COLORADO'S LAST GREAT SKI TOWN"

Thirteen spots are already filled on this long-awaited trip to Crested Butte. Few places remain that can be called a true Colorado ski town. Crested Butte is considered a holdout, retaining its small town charm and the adventurous soul it has always had as a historic mining town. From the abundant wide open green and blue groomed trails, to more advanced long cruisers and the famous extreme limits of the North Face and Headwall, the mountain has it all.



Off slope, the fun doesn't stop. For a small town like this to have three locations for sushi, six great pizza places, and more than 30 bars is hard to believe. There is also live music almost every night at places like the classic Eldo bar or the intimate Princess wine bar on Elk Avenue in downtown Crested Butte. The shopping is also an adventurous undertaking with small specialty shops and galleries to explore, each one distinct in its offerings and style.

The Cornhusker Ski Club has not been to Crested Butte since January 2000 - and many exciting mountain changes await us! This is our annual Flatland Ski Association trip.

Our sleeper bus departs Tuesday evening, January 24, 2012. We'll ski full days January 25-28 and an optional half day on January 29. Our bus departs for home Sunday afternoon, January 29, returning early Monday morning, January 30.

The trip price includes:

- * sleeper bus transportation;
- * 4 nights lodging at the Plaza Condominiums (2 and 3 bedroom condos, minimum occupancy);
- * 4-day lift ticket w/a 5th day optional (half day of skiing);
- * Club pizza party the first night;
- * FSA activity ticket, which provides two evening meals; and
- * Practice time on race course for our club only.

The Plaza Condominiums are located just 100 yards from the main Silver Queen quad lift, offering condo conveniences in a hotel-like setting. The Plaza is an easy walk to the action-packed ski area base and provides the most on-site amenities of any complex in Mt. Crested Butte, including a sauna, indoor & outdoor hot tubs, free village shuttle, lounge, restaurant and more.

Trip price includes:


- —five nights lodging at Avon by Beaver Creek in two-bedroom condos.

2011-2012 CORNHUSKER SKI CLUB TRIP POLICIES

1. When signing up for a trip, a deposit must be given to the Trip Captain with checks payable to the Cornhusker Ski Club, in order to reserve a place on the trip. \$15 of the deposit is non-refundable in the event that you cancel your attendance on the trip for any reason.

- 2. Once a trip is filled, no deposit is required for you to place your name on a
- 3. The balance of the trip fee is due according to announced schedules. If the Trip Captain does not have your money by this time, your name will be dropped and your reservation will be filled from the waiting list.
- 4. Cancellations will be accepted by the Trip Captain up to 90 days prior to departure of the trip. If you cancel within 90 days of the trip, your money will be refunded only if your place can be filled from the waiting list. Accommodations, travel and other costs will be refunded only if the reservations can be canceled or rearranged by the Trip Captain.
- 5. The Cornhusker Ski Club will not be liable for any canceled or altered services, including price increases, not initiated by the Cornhusker Ski Club.
 6. Membership in the Cornhusker Ski Club is mandatory for participation in organized trips.
- 7. Children under 18 who are members with parents, are welcome on trips when accompanied by a responsible adult.
- On all the trips, the bus will not wait for latecomers on either the trip out or the trip back.
- Bunk assignments are on a first-come basis, unless stated otherwise by the Trip Captain.
- 10. No seat swapping is allowed on the bus. The same order of seating enroute will be in effect on return unless exception is made by the Trip Captain, with concurrence of all involved.

- 11. Smoking is prohibited on the buses.
- 12. Hallucinogens (drugs) and /or marijuana are prohibited. Usage will be grounds for membership dismissal. The same applies to unruly behavior or profanity.
- 13. Lights out on return after 10:00 p.m., if the next day is a weekday.
- 14. Trips may be supplemented with drive-outs only on the condition of the bus being filled and that a hardship would not otherwise be imposed on others.
- 15. Trip Captains will have the final say on any discretionary matters. If there are any complaints, these should be reduced to writing and sent to the overall Trips Chair.
- 16. Cornhusker Ski Club is not responsible for any personal injury or property damage that may occur during a club organized function. Members assume all legal and financial responsibility for damage to any facilities used by them. If individual responsibility cannot be ascertained, cost of damages will pro-rated among room occupants. Members causing property damage can be dismissed from the club and denied new memberships as stated in the By-Laws.
- 17. The club is not responsible and shall not be liable for loss of personal property and/or delays or inconveniences sustained by any members or participant in any activity or trip arranged in whole or part by the Cornhusker Ski Club.
- 18. At Cornhusker Ski Club meetings and functions, members are prohibited from promoting any trips or activities except those organized by the Cornhusker Ski Club.
