### Upcoming Ski Trips

Welcome to ski season 2017-18!! Your trip coordinators and board members have worked together to offer two trips you will find affordable and enjoyable! Let the board members know if

you have a particular destination in mind and we will continue working on the possibility.

**Early bird discount:** Sign up for a trip before October 1 and save \$50.00. There has been great success for planning purposes from the early signup so the board again voted to give our members a break on the trip prices to encourage participants to sign up early. Resorts are inserting earlier lodging cutoffs into their contracts so YOU save money by signing up early to accommodate the decisions.

**Solo bunks:** A solo sleeping bunk may be reserved on a first-come first served basis on both the Copper and Snowmass trips. Cost will be \$80.00 and available if the bus does not fill. Let your trip captain know and get on the list!

**New member discount:** New members are given a \$25.00 discount upon trip signup. Please encourage people you have met that ski/board to join us and mention this discount. A person that has been a member in the past (before May 1, 2014) that renews membership could also be eligible for this discount on a trip.

### Copper Mountain—A Colorado Gem!!

Copper Mountain is a great destination for the Cornhusker Ski Club's first trip of the season. The mountain has everything--naturally divided terrain with areas for beginners, intermediates, advanced and even the dare-devils! The Super-Bee and two centrally located quads keep the lift lines to a minimum and the abundant snow-making will enhance our ski terrain. Our condos will be centrally located and we offer a pizza party the first night of our 3-night stay!

**Dates:** Depart Friday evening, December 8 and return early Wednesday morning, December 13.

**Ski & lift ticket dates:** 4 days possible Saturday - Tuesday. You can choose 1, 2, 3 or a 4 day lift ticket. Many have pre-purchased a 4 day or season pass for Copper Mountain.

**Condo:** Three nights in Copper Village Condos in Copper Village, a 5 minute walk to the American Eagle & American Flyer quads.

**Welcome/pizza party:** First night, we will enjoy a club pizza party.

**Price for transportation, lodging, bus beverages and welcome party, NO lift tickets: \$325.00 BEFORE OCTOBER 1.** \$150.00 deposit, remainder due by October meeting. After October 1, trip price increases to \$375.00 so sign up early!

**Lift tickets** are an additional \$68.00 per day (2 day=\$136, 3 day=\$204, 4 day=\$272).

Yes, FSA is going back to Snowmass! This trip is a triple-whammy with great ski terrain to ski AND racing AND parties. Snowmass is known for lots of “bluebird” days, stellar natural snow along with snowmaking. The entire scenario is awesome: lifts, grooming, terrain variety, on-mountain food and yes,

we mentioned grooming! Try the daily noon groom for a quick energy boost before heading in to lunch.

Then there are the other 3 mountains available on the same lift ticket and with free bus service: Aspen Mountain (Ajax) with the town of Aspen at the base, Aspen Highlands, and Buttermilk/Tiehack. All of the mountains are easily accessible and great fun to ski for even more diversity on one lift ticket. Party, party, party with new friends and old!

The Cornhusker Club will enjoy a pizza party the first night of the stay with an FSA welcome party the next evening. Friday brings a free evening to check out the town of Aspen and the last evening will be the annual FSA awards banquet.

**DATES:** Depart Tuesday evening, January 30, 2018 and return early Monday morning, February 5, 2018.

**SKI DATES:** Wednesday, January 31 through Sunday, February 4. A 4 day lift ticket is included in the cost of the trip. A 5<sup>th</sup> day lift ticket is available for \$72.00. Contact the trip captain for other lift ticket possibilities. If you are over 65 years old, a reduced price lift ticket is offered.

**CONDO:** Four nights at Snowmass Mountain Condos. These condos are off-mountain & require a shuttle but are very convenient for our group. We are offering a mixture of 2 and 3 bedroom condos. Please let the trip captain know who you would like to share a room with. He would also like to know if you have condo-mate preferences.



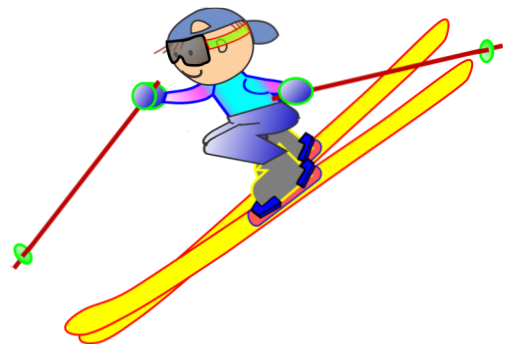
**COST OF TRIP:** Before October 1, \$985.00 includes transportation, lodging, 4-day lift ticket, activity ticket, bus beverages, and welcome party. If you are over 65, subtract \$60.00 for reduced price lift ticket or \$925.00. Prices after October 1 will be \$1,035.00 or \$975.00 if over 65.

**DEPOSIT:** \$200.00 to reserve your place on the trip. Payments of \$250.00 each will be due at the September and October meetings with the remainder owed at the November meeting.

**DRIVE/FLY OUTS:** The board of CSC is again offering a discounted price for those flying or driving to Snowmass. Deduct \$150.00 if you are providing your own transportation. Early bird price will be \$835.00 or \$775.00 if you are over 65.

**SOLO BUNK:** Please let the trip captain know if you want be added to a list for a solo bus bunk for \$80.00. This offer is first-come, first-served based on availability.

### CORNHUSKER SKI CLUB TRIP POLICIES

1. When signing up for a trip, a deposit must be given to the Trip Captain with checks payable to the Cornhusker Ski Club, in order to reserve a place on the trip. \$15 of the deposit is non-refundable in the event that you cancel your attendance on the trip for any reason.
2. Once a trip is filled, no deposit is required for you to place your name on a waiting list.
3. The balance of the trip fee is due according to announced schedules. If the Trip Captain does not have your money by this time, your name will be dropped and your reservation will be filled from the waiting list.
4. Cancellations will be accepted by the Trip Captain up to 90 days prior to departure of the trip. If you cancel within 90 days of the trip, your money will be refunded only if your place can be filled from the waiting list. Accommodations, travel and other costs will be refunded only if the reservations can be canceled or rearranged by the Trip Captain.
5. The Cornhusker Ski Club will not be liable for any canceled or altered services, including price increases, not initiated by the Cornhusker Ski Club.
6. Membership in the Cornhusker Ski Club is mandatory for participation in organized trips.
7. Children under 18 who are members with parents, are welcome on trips when accompanied by a responsible adult.
8. On all the trips, the bus will not wait for latecomers on either the trip out or the trip back.
9. Bunk assignments are on a first-come basis, unless stated otherwise by the Trip Captain.
10. No seat swapping is allowed on the bus. The same order of seating en route will be in effect on return unless exception is made by the Trip Captain, with concurrence of all involved.
11. Smoking is prohibited on the buses.
12. Hallucinogens (drugs) and /or marijuana are prohibited. Usage will be grounds for membership dismissal. The same applies to unruly behavior or profanity.
13. Lights out on return after 10:00 p.m., if the next day is a weekday.
14. Trips may be supplemented with drive-outs only on the condition of the bus being filled and that a hardship would not otherwise be imposed on others.
15. Trip Captains will have the final say on any discretionary matters. If there are any complaints, these should be reduced to writing and sent to the overall Trips Chair.
16. Cornhusker Ski Club is not responsible for any personal injury or property damage that may occur during a club organized function. Members assume all legal and financial responsibility for damage to any facilities used by them. If individual responsibility cannot be ascertained, cost of damages will pro-rated among room occupants. Members causing property damage can be dismissed from the club and denied new memberships as stated in the By-Laws.
17. The club is not responsible and shall not be liable for loss of personal property and/or delays or inconveniences sustained by any members or participant in any activity or trip arranged in whole or part by the Cornhusker Ski Club.
18. At Cornhusker Ski Club meetings and functions, members are prohibited from promoting any trips or activities except those organized by the Cornhusker Ski Club.
