If you read this article in the last newsletter, updates are **blue bolded**. New readers, don't miss ALL the details!

We're heading back to Snowmass this season...with a BUS option! **We currently have 15 signed up to ride the bus and another 6 flying/driving out.**

Snowmass is known for lots of powder days and "bluebird" skies. Three other mountains are also available on the same lift ticket with FREE bus service to them: Aspen Mountain (Ajax) with the town of Aspen at the base; Aspen Highlands; and Buttermilk/Tiehack. All four mountains are easily accessible and great fun to ski. Only skiing three days? Have a day of fun in Aspen (shopping, tours, lunch, etc.) or take the bus to Glenwood Springs to enjoy the hot springs & spa.

And what else makes a ski trip shine? The ideal lodging! Tamarack is in a great location with high quality and numerous amenities. Here are the trip details:

**DATES:** Depart Thursday **MORNING**, December 9. **Load at 7:30 a.m., depart at 8:00 a.m.** on a Windstar Lines bus with quick stop to pick up pre-ordered boxed lunches (included in the bus-riding price!) in Ogallala.

**SKI DATES:** Friday, December 10 through Monday, December 13, 2021

**RETURN:** **Load bus on Monday, December 13, at 4:00 p.m. and depart at 4:30 p.m.** We'll stop at Eagle for fast food on the way home and arrive in Lincoln early Tuesday morning, December 14.

**BASIC TRIP PRICES:**

- **ON THE BUS: \$680 - includes transportation and a SOLO bunk, lodging, bus box lunch & bottled water. Due to our current smaller group size this is BYOB if you want to bring a smaller cooler of adult beverages on the bus with you.**
- **DRIVE/FLY OUT: \$380.00 - includes lodging only. Note that our condo management provides FREE shuttles from/to Aspen Airport.**
- **Deposit schedule: \$300.00 upon sign-up; balance due (including add-on lift tickets) by October 19.**

**ADD-ON LIFT TICKETS:** Lift tickets to ski ALL 4 MOUNTAINS are available as trip add-ons, with full payment due by October 19. Two levels of lift tickets for your choice of 3 or 4 days:

Regular = 3-day is \$225; 4-day is \$300.

Senior 65+ rate = 3-day is \$165; 4-day is \$220.

**CONDO: Tamarack Townhomes:** We have contracted for minimum occupancy in **2-bedroom/2-bath and 3-bedroom/3-bath** units. There is a pool and two hot tubs in the complex. These units are right across the street from the lower base area of Snowmass. The 6-chair lift is located at this base area. The gondola is also within walking distance that travels towards the Elk Camp area. A 4-person foot traffic lift ("Skittles") takes us to the Village Mall where many restaurants and shopping are located. Ski rental is also in the lower base area.

**LOCAL TRANSPORTATION & GROCERIES:** A Village shuttle stop is right by the condos and the free bus service to the other mountains and Aspen is just across the street. A grocery store is within walking distance. **Due to COVID restrictions, group gatherings are discouraged so you will provide your own meals.**

**PRE-TRIP PARTY – CANCELLED.** **Due to a smaller group, the pre-trip party is cancelled. You will receive detailed trip information by email.**

The 2021-2022 membership form can be found in this newsletter. Membership is mandatory to participate in trips organized by the Cornhusker Ski Club. A completed and signed form must be submitted with dues payable to the Cornhusker Ski Club and the signed waiver/release form for communicable diseases, including COVID-19.



**To bus or not to bus to Telluride is the question for September meeting! A decision will be made after the September 21 meeting if CSC will have a bus option for the Telluride FSA trip. Please contact Jenny Simpson ASAP if you plan to ride the bus so the board members can make a solid decision on offering the bus as part of the trip. If the bus portion is cancelled, members will have to find their own transportation to the FSA trip.**





I am not sure how many of you have had the chance to visit and ski/board Telluride. If you have not, this trip would be one that you should sign up for. Telluride is the destination of our annual FSA trip, and it will not disappoint.

Telluride is located at the end of a canyon and surrounded by Colorado's most rugged peaks. Most people do not travel this far so there are hardly any lift lines. They get an amazing amount of powder every year. They have 125 runs over 2,000 acres. For those tracking their vertical feet the longest run is 24,288 ft! 23% of runs are easy, 36% of runs are intermediate and 41% difficult. (What a nice mix!) Also, great skiing for families.



Most people ski Telluride for the powder! For those that would like to come along and have not skied there is snowshoeing, sleigh rides, fat tire bike tours, sledding, horseback riding, dog sledding and more. These activities would also be fun for those who want a new experience on their non-ski day! (For the more adventurous there is also heli-skiing-it is a good thing I cannot afford this!!! Wink wink.) This is a once-in-a-lifetime opportunity! Telluride also has an amazing ski town, ranking alongside Park City & Aspen.



**DATES:** NEW DAYS THIS YEAR>>>> Depart Friday, January 21, 2022, on Windstar Lines. The bus will load in Lincoln on Friday, time TBD. Ski dates are January 22-25, and you may add the 26<sup>th</sup>. Bus will load on the 26<sup>th</sup> later in the afternoon (TBD). Will stop along the way for dinner. We will return early morning, Thursday, January 27. (Add your name to a list for an available single bunk for \$80.00 round trip.)

**CONDOS:** We will be staying at Mountain Lodge Telluride. Their address is 457 Mountain Village Boulevard, Telluride, CO, 81435. We will have a mix of 2 & 3 bedrooms. This does have ski in/out access. They also have a ski shuttle. Amenities include free Wi-Fi, babysitting, bar, lounge, dining, outdoor pool & hot tub. They do have grocery delivery for a fee.

**TRIP PRICES:** First deposit is due before October 1, 2021, to save \$50 off the trip price. Prices listed below are with the \$50 off. If booking on or after October 1, add \$50 to the trip prices below. Prices below indicate base price; add the number and cost of lift tickets you plan to ski to the price. Many people have the Epic pass. You do need to ADD Telluride as it is NOT included in the base pass. If you are a new member, we do give an additional \$25.00 discount for one trip.

**-WITHOUT LIFT TICKETS:** \$760.00 before October 1 includes four nights lodging, sleeper bus, beverages, and the FSA activities. Deposit \$200.00 initial, \$250.00 due at the October 19 meeting, remainder due at the November 16 meeting. Drive/Fly out: Subtract \$230.00 = \$530.00

NOTE: If you happen to be over 80, lift tickets with our group are FREE!

-For those arranging your own transportation: Subtract \$230 if you are drive/fly out. The destination airport is MTJ (Montrose) if you plan to fly. This is about 65 miles from the resort. You can pre-book a private or shared shuttle from the airport to the resort. If driving, the resort does charge \$20.00/day and there is no free parking at Telluride.

## COPPER MOUNTAIN DRIVE-OUT 2022

One of the best Spring skiing/boarding destinations in Colorado is Copper Mountain and CSC is going back for the adventure! This will be a drive/fly out only trip with lodging for 28 members. Copper Mt. typically has some great “powder dumps” mid-February so this should be a great trip for those who seek an occasional powder day.

**Trip cost for early signups (before October 1): \$290.00.** Add \$50.00 if you book on/after October 1. Save your spot on this trip with a deposit of \$200.00.

**Lift tickets** will be an additional cost—3 days=\$227 and 4 days=\$301. This means that you can ski for just a little more than \$75.00 per day which is “awesome, awesome, awesome”!! There is no senior discount for lift tickets. If you purchased a four day pass through Copper Mt., you can also use that.

**Lodging:** Center Village 2-bedroom condos for four nights starting Sunday, February 27, with checkout on Thursday, March 3. If you want to stay overnight March 3, the cost is \$70 per person. There may be extra opportunities for those who want to extend their stay, but none for early check-ins.

**Driving:** One car is allowed per unit in the underground parking. Other vehicles will be parked in Lot A and require a parking pass (free of charge).

### Trip Insurance

It's been said that trip insurance is never needed until it's needed.

What should you know about trip insurance?

- You must purchase trip insurance coverage before it is needed. Once you recognize the need, it is too late to protect your trip.
- After the initial trip payment is made and you have a good grasp of your total expected trip cost, it is good time to get the most accurate quote.
- An example of coverage for a \$1,500 trip within the United States for a 60-year-old is approximately \$63 through [www.insuremytrip.com](http://www.insuremytrip.com).
- If you need coverage for a pre-existing medical condition, there are time-sensitive eligibility requirements tied to your initial trip payment and you may have a limited amount of time to buy a plan.

## CORNHUSKER SKI CLUB TRIP POLICIES

1. Membership is mandatory to participate in trips organized by the Cornhusker Ski Club. A completed and signed Cornhusker Ski Club membership form must be submitted with membership dues payable to Cornhusker Ski Club.
2. To reserve a place on the trip, a deposit must be given to the Trip Captain with checks payable to the Cornhusker Ski Club. \$15 of the deposit is non-refundable in the event that you cancel your participation on the trip for any reason.
3. The balance of the trip fee is due according to announced schedules. If the Trip Captain does not have payment by these dates, your name will be dropped and your reservation filled from the waiting list.
4. Once a trip is filled, no deposit is required to place your name on a waiting list.
5. Trip cancellations or changes will be accepted by the Trip Captain up to 90 days prior to trip departure. Cancellations or changes within 90 days of the trip departure will be refunded only if you find a replacement, or if the Trip Captain can fill your place from the waiting list. Refunds are subject to the \$15 non-refundable deposit. **Purchasing individual trip insurance is recommended.**
6. The Cornhusker Ski Club will not be liable for any canceled or altered services, including price increases, not initiated by the Cornhusker Ski Club.
7. Children under 18 who are members with parents, are welcome on trips when accompanied by a responsible adult.
8. On all the trips, the bus will not wait for latecomers on either the trip out or the trip back.
9. Bunk assignments are on a first-come basis, unless stated otherwise by the Trip Captain.
10. No seat swapping is allowed on the bus. The same order of seating en route will be in effect on return unless exception is made by the Trip Captain, with concurrence of all involved.
11. Smoking is prohibited on the buses.
12. Hallucinogens (drugs) and /or marijuana are prohibited. Usage will be grounds for membership dismissal. The same applies to unruly behavior or profanity.
13. Lights out on return after 10:00 p.m., if the next day is a weekday.
14. Trips may be supplemented with drive-outs only on the condition of the bus being filled and that a hardship would not otherwise be imposed on others.
15. Trip Captains will have the final say on any discretionary matters. If there are any complaints, these should be reduced to writing and sent to the overall Trips Chair.
16. Cornhusker Ski Club is not responsible for any personal injury or property damage that may occur during a club organized function. Members assume all legal and financial responsibility for damage to any facilities used by them. If individual responsibility cannot be ascertained, cost of damages will pro-rated among room occupants. Members causing property damage can be dismissed from the club and denied new memberships as stated in the By-Laws.
17. The club is not responsible and shall not be liable for loss of personal property and/or delays or inconveniences sustained by any members or participant in any activity or trip arranged in whole or part by the Cornhusker Ski Club.
18. At Cornhusker Ski Club meetings and functions, members are prohibited from promoting any trips or activities except those organized by the Cornhusker Ski Club.

## WAIVER/RELEASE FOR COMMUNICABLE DISEASES INCLUDING COVID-19

The novel coronavirus, COVID-19 has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. As a result, federal, state and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

In consideration of being allowed to participate in, as a member or guest ("Releasor") of the Cornhusker Ski Club and related events and activities, the undersigned acknowledges, understands, and agrees that:

1. Participation in Cornhusker Ski Club events, trips and/or other gatherings includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist;
2. Participation in Cornhusker Ski Club events may potentially bring Releasor in close contact with other individuals and locations including, but not limited to, ski resorts which have been known sources of exposure to COVID-19;
3. **Releasor knowingly and freely assumes all such risks**, both known and unknown, **even if arising from the negligence of the releasees** or others, and assumes full responsibility for Releasor's participation in Cornhusker Ski Club events, trips and/or other gatherings;
4. # Cornhusker Ski Club Covid Policy.      Effective 8.29.21

To participate in CSC sponsored ski trips, the policies regarding the current COVID 19 outbreak

-

## Provided Bus Transportation

- All passengers on the bus must have a current fully-vaccinated Covid card
- Passengers on the bus will not be required by CSC to wear a mask - the bus company may implement masks requirements prior to departure.
- Masks may be worn by individuals who desire additional protection
- CSC anticipates that youth vaccinations will be available prior to this years trips
- Unvaccinated participants will need to arrange for their own transportation to the ski area

## Provided Lodging

- Unvaccinated participants will be required to provide proof of a negative Covid test within 72 hours of their expected arrival at the lodging site - persons testing positive will be excluded from the trip
- Unvaccinated participants will also need to make arrangements with other participants (vaccinated or unvaccinated) to share a condo with. The expense for empty beds in a given condo will be the financial responsibility of the unvaccinated participant.
- Your trip captain may be able to help identify other unvaccinated participants for you to coordinate with.

## Cornhusker Ski Club

- Vaccinated participants must send a photo or scanned copy of their vaccination card to the membership chair - [csc.ne.membership@gmail.com](mailto:csc.ne.membership@gmail.com)
- CSC will store this information along with other membership information, and will advise trip captains which participants have a vaccination card.
- CSC will monitor local health mandates, and advise members as information becomes available.
- CSC advises all members to consider Trip Insurance in the event that a Covid infection or test results in being unable to attend a trip.
